District Financials

District PTO Fund Balance: \$ 22,080.89

This does not include pending checks from Buona Beef Dinner out in March, Fuddruckers in March and Papa Passero's in April. Also pending is the April Market Day profit of \$735.10. The District Fundraiser profit of \$14,274.17 will also be added to the PTO balance.

District PTO is requesting that each school's submissions for reimbursement for the current year need to be turned into the district office by the 15th of June 2008.

Individual PTO Budgets for 2008-2009

Each school's PTO provided a financial budget for the 2008-2009 school year at this meeting for review and approval. All three schools requested to continue the same monetary budget as this past school year. Lakeview's budget was for \$8500, Prairieview's budget was for \$8600 and Ide's budget is for \$8950. A motion was made by Luanne Flynn for approval of new budgets for 08-09 and the motion passed.

District PTO Donation

Discussion held regarding amount of donation back to District 66 for technology fund. Reviewed potential incoming revenues and the possible expenditures for the end of the school year. Motion made by Luanne Flynn and second by Melynda Onusaitis to leave at least \$4000.00 for Start Up costs for the District PTO for 2008-2009 school year. Motion passed. Liane Raso to contact board in July once the account is balanced. District donation amount will be determined by account balance.

2. Market Day

Paul Knight and Christina Wiseman are the district chairs this year. The next date of the sale is May 24th, 2008 and June's Market Day will be held on June 21st, 2008. Volunteers needed from 9:30am until 11am. Pick up will be from 11am until noon. April's sale totals = \$735.10. Next year the Pick Up dates have changed and will be the first weekend of the month and have a new pick up time of 9:30 to 10:30am. The following dates are set for the school year of 2008-2009: Sept 6th, Oct 4th, Nov 1st, Dec 6th, Jan 10th, Feb 7th, Mar 7th, April 4th, May 2nd, and June 6th.
